## **Description**

Castrol Additiv<sup>™</sup> N is an ashless lubricity additive formulated with special fatty acids, emulsifiers and surface active compounds. When used, the additive increases lubrication properties to ensure superior machining performance and tool life. It can be used in single sump machines as well as central systems.

## **Application**

Castrol Additiv N is especially formulated for use with Castrol's neat cutting and grinding oils. Due to its superior wetting properties and excellent surface activity, it acts as a strong lubricity additive especially for grinding oils.

#### **Recommended Concentrations**

Castrol Additiv N should only be used after consultation with Castrol's Service Representative. Depending on the machining process, the recommended dosage can vary between 0.5 to 5% of the fluid volume. For grinding application, a lower dosage between 0.5 - 3% is recommended.

## **Storage**

To avoid product deterioration always keep the container/drum tightly sealed. Store the product in a cool, dry place away from direct sunlight. Prevent exposure to frost and avoid water ingress. For optimum product stability, it is preferable to store the product indoors between 5°C and 45 °C / 41°F and 113°F.
