#### Description

Castrol Demulsifier<sup>™</sup> 702 is a water based demulsifing agent. It can be used in single sump as well as central systems.

## Application

Demulsifier 702 is recommended for use in water based metalworking fluids to help split the oil from the fluid and increase the oil separating ability of the fluid. A secondary effect of Castrol Demulsifier 702 is that it helps reduce the foam creation in the metalworking fluid.

## **Conditions of Use**

Demulsifier 702 should only be used upon recommendation of Castrol's Service Representaive. Recommended concentration is between 0,01-I 0,03 % depending on the amount of emulsified oil.

#### Storage

To avoid product deterioration always keep the container/drum tightly sealed. Store the product in a cool, dry place away from direct sunlight. Prevent exposure to frost and avoid water ingress. For optimum product stability, it is preferable to store the product indoors between  $5^{\circ}$ C and  $45^{\circ}$ C /  $41^{\circ}$ F and  $113^{\circ}$ F.
